WINBETGO.COM - REFER A FRIEND PROGRAM - TERMS AND CONDITIONS

A. Introduction

This Refer a Friend Program (the "*Program*") sets out the complete terms and conditions governing the Referrer's ability to use the Company's 'Refer a Friend functionality' and forms an integral part of the "*WinBetGo - Terms and Conditions*" and provisions set herein are considered as an annex of all "*WinBetGo - Terms and Conditions*".

Please read carefully all the terms and conditions set out herein before applying to participate in the said Program. You must agree with and accept all the terms and conditions contained in Program without modifications, which include those terms and conditions expressly set out below and those incorporated herein by reference, before you may participate to the Program.

This Agreement sets out the terms and conditions upon which the Company may provide the Refer a Friend functionality to the Referrer whereby the Referrer will have the ability to invite their friends (i.e., the Referees) to the Company and generate commissions (i.e., *Reward*) based on the traffic brought to the Company.

All the terms and conditions and all provisions set out in this Agreement, governing the business relationship of the Referrer and the Referee with the Company shall remain in full force and effect.

B. Parties to the Agreement

WinBetGo.com Company operating under the name WinBetGo is a Data Service Provider;

and

The respective "Referrer", who shall mean the individual who is a member to WinBetGo's Refer a Friend Programin accordance with the terms and conditions set in this Agreement, and who agrees with and accepts the terms and conditions of the Program set forth herein and the participation of whom to this Program has been accepted by the Company (hereinafter called the "*Referrer*"):

and

The respective "Referee", who shall mean the individual who has registered to open an WinBetGo account with the Company, through the Refer A Friend Program in accordance with the terms and conditions set in this Agreement, and who agrees with and accepts the terms and conditions of the Program set forth herein and the participation of whom to this Program has been accepted by the Company (the "*Referee*");

and furthermore, may hereinafter be referred to separately as the "Party" and jointly as the "Parties".

 The "Refer a Friend Program" Terms and Conditions is an integral part of the "WinBetGo - Terms and Conditions" and provisions set herein are considered as an annex of all "WinBetGo - Terms and Conditions".

C. Definitions of terms

Capitalised terms used in this Agreement, not otherwise defined herein, shall have the meanings set forth and given to them in the Company's Terms and Conditions of Business/Client Agreement. Any defined terms herein shall complement the terms defined in the Company's Terms and Conditions of Business/Client Agreement.

Agreement	Means the current agreement, inclusive of all its terms and conditions.

MyWallet	Means the electronic wallet linked with the Referrer's account(s) where he/she is paid a predefined amount of funds (i.e., Rewards) by the Company based on the traffic brought.		
Referee	Means the person / friend whom the Referrer invited to the Company through the Refer a Friend Program and who meets all the eligibility requirements set in this Agreement.		
Referrer	Means the person, who has a business relationship with the Company and who meets the eligibility requirements to participate in the Refer a Friend Program through which he/she is able to invite friend (i.e., Referees) to the Company, via the Refer a Friend functionality.		
Reward	Means a predefined amount of money generated in accordance with the Company's Refer a Friend functionality.		

D. Acknowledgements and Confirmations of Eligibility

- 1. The Referrer, who meets the eligibility requirements set hereinbelow in Section E.1, may participate in the Refer a Friend Program which can be found in his/her Members Area. Referrers shall invite his/her friends (the "Referees") to the Company via a dedicated link provided by the Company's Refer a Friend functionality or via email including the dedicated link.
- 2. A successful Referee is an individual who registers and purchases a paid plan with the Company, through the dedicated link or email provided by the Referrer, and his/her account is verified.
- 3. The Referee shall also be able to participate in the Refer a Friend Program as Referrers, provided that the eligibility requirements set in hereinbelow in Section E.1 are met.
- 4. The payment of the amount of Rewards shall be made to the Referrer's "MyWallet", provided that the generated Reward is not the result of Fraud Traffic and/or of any trading activity that is in violation of this Agreement or of the Company's Terms and Conditions, which govern the business relationship between the Parties.
- 5. The Referrer shall, under no circumstances, be considered as an Agent/Representative of the Company.
- 6. Should the activity/behavior on the Referrer's account(s) be detected violating the Company's Terms and Conditions and/or this Agreement or should the Rewards generated related to allegedly fraudulent account(s), the Company reserves the right to exclude the Referrer from participating to the Program and/or terminate the business relationship withthe Referrer.
- 7. The Parties (i.e., the Referrer and Referee) hereby acknowledge and accept that the Company may adjust/re-adjust the Reward of the Referrer at its sole and absolute discretion. The Referrer further acknowledges and accepts that the latter may potentially affect any payable Rewards.
- 8. The Parties (i.e., the Referrer and the Referee) hereby acknowledge and confirm that this Program is discretionary, and the Company reserves the right to terminate this functionality at any time with prior notice.

E. Specific "Refer a Friend Program" conditions of eligibility

- 1. In order for a client to be able to participate in the Company's "*Refer a Friend Program*" (i.e., Referrers) through their Members Area, the Referrer must be validated.
- 2. For the purpose of this Agreement, a successful referral is based on a-per-client basis (i.e., per Referee).
- 3. Referrers, who participate in the "*Refer a Friend Program*" can invite their friends (i.e., Referees) to the Company via dedicated link, provided by the Company via their Members' Area. Referees will need to register an WinBetGo account through the link provided, within thirty (30) calendar days from the receipt of link and successfully open and verify their account.
- 4. The referral is considered successful only if the following requirements are met:
 - (a) The Referee must register, verify and sign up for one of the paid plans available at WinBetGo.com.
- 5. Subject to the requirements in Section E.4., below you may find some examples on how the reward will be counted towards the "*Refer a Friend Program*".

Example account(s):

Plan Type	Plan Cost	Commission %	Total Credit to Referrer
Free plan	\$0	0%	\$0
Paid plan	\$10	10%	\$1
Paid plan	\$90	10%	\$9

- 6. Referrers are not allowed to refer the same person, as Referee, more than once.
- 7. Referrers are not allowed to invite existing WinBetGo accounts/users to the Program.
- 8. Subject to the requirements set in Section E.4., the Referrer will be rewarded with 10% (teen percent) of the value plan acquired by Referee in their "MyWallet" on a monthly basis and more specifically, every first Monday of the Month.
- 9. The Referrer of a WinBetGo account cannot be changed, exchanged or deleted.
- 10. Credits will be granted monthly and in installments (if the contracted plan is longer than 30 days). Each installment will always be credited after a new 30-day cycle of use of the contracted paid plan has been completed:

For example, a 90-day plan. 90 days divided by 30 days is 3 cycles of 30 days. Therefore, there will be 3 installments (cycles), where the first will be credited within 10 days after the first 30 days of use of the paid plan;

The second installment will be credited within 10 days after another 30 days of use of the paid plan (thus completing 60 days of use);

The third installment will be credited within 10 days after another 30 days of use of the paid plan (thus completing 90 days of use) and so on, according to the total number of days of the paid plan contracted by your referral.

Plan Days x Plan Cost x Number Installments examples are below:

F. Specific "MyWallet" Terms

- 1. Each Referrer will have a unique "MyWallet" linked with their account which it was initially registered with our Company in order to participate to the "*Refer a Friend Program*".
- 2. Referrers will have access to their "MyWallet" through their Members Area once they start inviting friends.
- 3. Subject to Section E.8, any Rewards generated will be added to the Referrer's "MyWallet" as credit. Referrer's will be able to access and monitor their "MyWallet's" history via their Members Area.
- 4. The "MyWallet's" base currency shall be in USD. Transfers from "MyWallet" are subject to conversion fees in case their base currency is not the United States Dollar ("USD").
- 5. Any Rewards generated by the "Refer a Friend Program" may be used to purchase a paid plan linked to "MyWallet" or to withdraw using the methods provided on WinBetGo.com. The minimum transfer amount shall be USD 20.

G. General Terms

- 1. The Company reserves the right, at its reasonable discretion:
 - i. to decline registration of any participant in the "Refer a Friend Program"; and
 - ii. disqualify any participant in the "*Refer a Friend Program*" who tampers or attempts to tamper with the operation of the "*Refer a Friend Program*" or breaches these terms and/or any of the "*WinBetGo-Terms and Policies*" set forth on the Company's website.

Under no circumstances shall the Company be liable for any consequences of any credit/cashrewards cancelation or decline.

- 2. The Company reserves the right, at its reasonable discretion, to discontinue the offering of this "*Refer a Friend Program*" to any of its clients, without having to explain the reasons. Such clients will be informed via email.
- 3. Any indication or suspicion, in the Company's sole discretion, of fraud, manipulation or any other forms of deceitful or fraudulent activity, will nullify all previously credited of the Parties' account(s) with the Company and/or all transactions carried and/or Rewards garnered therein. In these circumstances, the Company reserves the right, at its sole discretion to close/suspend (either temporarily or permanently) all such Parties' account(s) with the Company, cancel all Rewards of such Parties. In these circumstances, the Company shall not be liable for any consequences of the cancelation.

I. Termination

- 1. Either of the Parties (i.e., Company or Referrer or Referee) may terminate this Agreement by giving five (5) business days' written notice to the other Party.
- 2. The Company reserves the right to terminate or suspend without notice, this Agreement or any rights of the Referrer or Referee that they may possess under the provisions of this Agreement due to any

malpractice, breach of any provisions of this Agreement, failure of compliance with Applicable Laws and Regulations or other significant event, including liquidation or insolvency on the part of the Referrer or Referee. Such termination will be at the sole discretion of the Company.

3. Upon termination of this Agreement, the Company shall pay the Referrer any Rewards due as set out in this Agreement.

J. Governing Law and Language

- 1. The "Refer a Friend Program" terms shall be governed by and construed in accordance with the Laws of Belize. Any dispute or situation not covered by these terms will be resolved by the Company in the manner it deems to be the fairest to all concerned. That decision shall be final and/or binding onall entrants. No correspondence will be entered into.
- 2. If any of "*Refer a Friend Program*" terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.
